

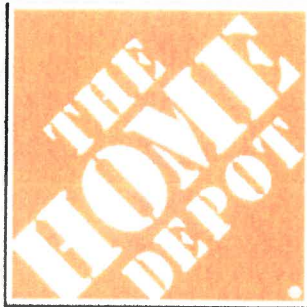

SIERRA LAKES WEST SIGN CRITERIA

I. GENERAL INFORMATION:

The intent of this sign criteria is to provide the guidelines to achieve a visually coordinated, balanced and appealing sign environment, harmonious with the architecture of the project, while maintaining provisions for individual graphic expression.

The sign regulations herein have been established for the purpose of achieving the best possible effect for store identification, while allowing each Tenant creativity within the limit of their leasehold.

II. APPROVALS

A. It is a mandatory requirement that the design and construction of Tenant's exterior signs receive written approval by Lewis Retail Centers prior to fabrication and installation. For purpose of the document "Lewis Retail Centers" will from hereon be known as "Landlord".

Landlord's approval shall be based on:

1. Conformity to the sign criteria established for the center, including the fabrication and method of installation.
2. Final approval upon viewing of final sign installed, making sure plans submitted and approved were followed.
3. Landlord has the specific right to refuse approval of any sign design which does not conform to this specific criteria.

B. To secure Landlord's approval, Tenant agrees to conform to the following procedures:

1. Three (3) copies of the detailed sign design. One to be in full color of the proposed sign or signs, submitted to Landlord.
2. The detailed sign design shall be submitted on sheets of 11" x 17"

- C. All sign designs and specifications are to be prepared by a reputable licensed sign contractor. The sign drawings must indicate the following information:
1. A scaled leasehold/storefront drawing illustrating the proposed sign design and all dimensions, as it relates to the leasehold/storefront elevation including side or rear elevations. The drawings are to include all exterior or window signs being requested for store usage.
 2. A plot plan and elevation indicating the exact location of each Tenant's sign as it relates to the building.
 3. A detailed letter through cross section of the sign and building fascia to show its construction and method of attachment.
 4. All aluminum, Plexiglas colors, paint finish colors with color swatch and material specifications.
 5. Neon tubing or LED sizes, color, intensity and transformer size.
- D. All drawings marked "Disapproved" or "Revise and Resubmit" must be changed as noted and resubmitted to Landlord as specified in section "II. APPROVALS, "B", "1". Drawings marked with "Approved as Noted"; do not require resubmittal as long as all required revisions are made.

Tenant or tenant's sign contractor will not be permitted to commence installation of any exterior sign, unless the following conditions are met upon Landlord's approval:

1. No sign shall be installed until a design review Sign Application as approved by the City of Fontana Planning Department and permits from the City of Fontana Building and Safety Department have been secured by the sign contractor
2. A "Permitted" stamped set of the final sign drawings are retained on Tenant's premises at all times during the installation of sign or signs, until a City Inspector has signed off on and approved final inspection.

III. CENTER IDENTIFICATION SIGNS:

A. Identification Signs:

Project developer shall erect the following:

1. **Center Identification Sign.**

Quantity: Project Developer shall erect one (1) water feature center monument identification sign.

SIERRA LAKES WEST SIGN CRITERIA

Size: Monument shall not exceed 6' -0" in overall height. Signage area shall not exceed eighty (80) square feet per side not including structure.

Location: Monument sign to be placed on intersection of Citrus Avenue and Sierra Lakes Parkway.

Copy: Monument sign to display center name "SIERRA LAKES WEST" on center section.

2. Center Identification Freeway Pylon Sign.

Quantity: Developer shall erect one (1) internally illuminated center identification freeway pylon sign.

Size: Center identification pylon sign shall not exceed forty feet (40' -0") in overall height. Sign area shall not exceed two hundred (200) square feet per side, not including structure.

Location: Center identification freeway pylon sign shall be located along the 210 Freeway as per attached site plan.

Copy: The freeway pylon sign shall display the shopping center name, "Sierra Lakes West", along with tenant names and logos. Sign shall also display "City of Fontana" as shown on the attached exhibit. Availability and positioning of tenant panels is at the discretion of the Landlord. Copy shall consist of channel letter and/or routed aluminum panels.

3. Multi-Tenant Monument Signs.

Quantity: Developer shall erect two (2) internally illuminated multi-tenant monument signs.

Size: Monument signs shall not exceed six feet (6' -0") in overall height. Signage area shall not exceed one hundred (60) square feet per side.

SIERRA LAKES WEST SIGN CRITERIA

Location: Monument signs shall be located as per attached site plan. Monument signs cannot impede the line of sight of vehicles and must be placed behind the sidewalk and at least twenty feet (20'-0") away from any point of ingress and egress.

Copy: Signs shall display tenant names and/or logos. Availability and positioning of tenant panels is at the discretion of the Landlord. Copy shall consist of channel letter and/or routed aluminum panels.

4. Service Station Pricing Monument Signs.

Quantity: Two (2) double face illuminated service station pricing monument signs.

Size: Service station monument signs shall not exceed six feet (6'-0") in overall height.. Signage area shall not exceed sixty (60) square feet per side, not including structure.

Location: The service station monument signs shall be placed along Sierra Lakes Parkway and Citrus Avenue. The service station pricing monument sign cannot impede line of sight of vehicles and must be placed 5'-0" behind the sidewalk and twenty (20) feet away from any point of egress and ingress.

5. Temporary Construction/Leasing Signs:

Quantity: Two (2) non-illuminated temporary construction/leasing/site signs.

Size: Temporary construction/leasing/site signs shall not exceed 15'-0" overall height.

6. Banners

No banners are allowed without expressed written consent by the Landlord. Any banners installed without Landlord approval shall be removed by the Landlord at their sole discretion. Any damage to the building caused by the installation of a banner or by the sign company shall be repaired by the Landlord and all related costs shall be the responsibility of the tenant. Upon Landlord approval, tenant must obtain a temporary sign permit from the City of Fontana prior to installation.

IV. TENANT IDENTIFICATION SIGNS

1. THE HOME DEPOT

Quantity: Tenant shall be allowed one (1) primary internally illuminated channel letter sign on each elevation. Tenant shall also be allowed four (4) secondary signs on the front elevation as well as directional signage related to the drive through.

Size: Primary tenant sign shall have 6'-0" maximum letter height. Secondary signs shall be allowed with a maximum channel letter size of 2'-0", except for the double line "Tool Rental Center" which shall not exceed 3'-0".

Location: Landlord shall reasonably approve location of tenant signs which shall be in keeping with the architectural design of the building.

2. PAD TENANT - MULTI-TENANT

Quantity: Each multi-user pad Tenant shall be permitted one (1) internally illuminated channel letter sign for their front elevation. If a Tenant's leasehold has a wall facing on the street and/or parking lot, an additional sign shall be allowed or as approved by Landlord. If the Tenant is located in an end space of the building, Tenant may install a third channel letter sign, one (1) one each frontage.

Size/Area: Maximum height of signs is two feet (2'-0") for a single line sign and two feet six inches (2'-6") for a double line sign. Tenant shall not exceed 70% of building leasehold width for each elevation. If a tenant has a nationally recognized logo or layout that cannot be modified and cannot meet the height restriction, the sign can exceed the height restrictions up to a maximum overall height of four feet (4'-0") but must be approved by the Landlord and the City of Fontana. Height and size must be in scale with the architecture of the building and all signage must be reviewed and approved by the Landlord and City of Fontana.

Location: Landlord shall reasonably approve location of tenant sign which shall be in keeping with the architectural design of the building.

SIERRA LAKES WEST SIGN CRITERIA

4. PAD TENANT – SINGLE USER

Quantity: Each single user pad Tenant shall be permitted four (4) internally illuminated channel letter signs, one (1) on each elevation.

Size/Area: Maximum height of signs is two feet (2'-0") for a single line sign and two feet six inches (2'-6") for a double line sign. If a tenant has a nationally recognized logo or layout that cannot be modified and cannot meet the height restriction, the sign can exceed the height restrictions up to a maximum overall height of five feet (5'-0") but must be approved by the Landlord and the City of Fontana. Height and size must be in scale with the architecture of the building and all signage must be reviewed and approved by the Landlord and City of Fontana. Tenant shall not exceed 70% of building leasehold width for each elevation.

Location: Landlord shall reasonably approve location of tenant sign which shall be in keeping with the architectural design of the building.

4. PAD TENANT – FUEL CENTER

Quantity: The fuel center Tenant shall be permitted four (4) internally illuminated signs, one (1) on each elevation of the gas canopy as well as two (2) signs on the building or kiosk.

Size/Area: Maximum height of signs is two feet (2'-0") for a single line sign and two feet six inches (2'-6") for a double line sign. If a tenant has a nationally recognized logo or layout that cannot be modified and cannot meet the height restriction, the sign can exceed the height restrictions up to a maximum overall height of five feet (5'-0") but must be approved by the Landlord and the City of Fontana. Height and size must be in scale with the architecture of the building and all signage must be reviewed and approved by the Landlord and City of Fontana. Tenant shall not exceed 70% of building leasehold for each elevation.

SIERRA LAKES WEST SIGN CRITERIA

SIGN SPECIFICATIONS

1. Signs shall be limited to store name, Federal or State registered name or logo. Established trade marks or registered trade mark signage shall be permitted providing the signs conform to the criteria described herein.
2. In the event the Tenant does not have an established exterior sign identity, the Landlord recommends the Tenant establish an acceptable letter style.
3. All letters shall be aluminum channel letters with face colors and type styles subject to Landlord's approval.
4. Logo cabinet plaques used in conjunction with individual letters will be considered a part of the sign area and are subject to Landlord's approval.
5. The Tenant shall pay for all signs, their installation, including final connection, and maintenance. Tenant's sign contractor must file and obtain any licenses, permits and variances as required for sign installation by the City of Fontana. A copy of the sign permit to be supplied to Landlord for their file.
6. Each Tenant or their sign contractor shall be responsible for the repair of any damage to the building caused by the installation of said Tenant's sign. Only State licensed and insured sign contractors shall perform sign manufacturing and installations. The sign contractor to supply Landlord with a copy of their State License and Workmen's Compensation Insurance.
7. Each Tenant shall be responsible for the performance of its sign contractor.
8. Tenant shall be responsible for removal of said sign within thirty (30) days after vacating the site. Removal of the sign shall include the repair and restoration of the wall surface back to the original condition and must undergo final inspection by Landlord.
9. Each Tenant shall be responsible for keeping all their signage or graphics on its premises in good working order. Landlord shall inform Tenant, in writing, of non-acceptable conditions, if lighting is out or if the sign is in poor visual condition. Repairs shall be made by Tenant within thirty (30) days from receipt of such written notice.
10. Tenant shall also install vinyl lettering on their storefront showing the hours of operation, emergency contact numbers, etc. Maximum area shall be 2'-0" x 2'-0". Vinyl lettering shall be white in color. Content and font shall must be reviewed and approved by Landlord.

SIERRA LAKES WEST SIGN CRITERIA

A. FABRICATION AND INSTALLATION OF ILLUMINATED CHANNEL LETTERS

The fabrication and installation of all signs shall be subject to the following restrictions:

1. All channel letters are to be fabricated from .050 to .125 aluminum. Letters must be fabricated of aluminum with aluminum backs. No stapled letters shall be allowed. A minimum of five (5) inch deep letter returns shall be primed and painted with an automotive enamel, a minimum of two (2) coats of semi-gloss paint. Unless color is approved by Landlord. Interior of letter to be primed and painted a reflective white to assist with even lighting.
2. Letter faces shall be a minimum of 1/8" thick, translucent Plexiglas. Colors are subject to Landlord approval.
3. Retainer trim cap shall be 3/4" dark bronze trim cap edge, unless otherwise approved by Landlord. All tenant colors are subject to Landlord approval
4. All channel letters to be illuminated with neon tubing with a 30 ma. Transformer. Neon tube size and color to be determined by channel letter face color. P.K. or Hage housings or other UL approved connectors may be used for all neon tube systems. All channel letters shall be UL labeled. LED illumination is allowed.
5. All channel letters shall be secured by concealed fasteners, stainless steel or nickel cadmium plated.
6. No exposed neon, incandescent or fluorescent lamps will be permitted.
7. All penetrations of the building structure required for sign installation shall be sealed to a water tight condition.

SIERRA LAKES WEST SIGN CRITERIA

8. No sign company labels will be permitted on the exposed surfaces of signs, except what is required by the City of Fontana.
9. All channel letters must have a 3/16" diameter drain hole at the bottom of each channel letter or plaque, if illuminated.
10. All signs shall be fabricated and installed with UL approval in compliance with all applicable building and electrical codes. UL sticker shall be placed in an inconspicuous location on letters.
11. All signs shall conceal all necessary wiring, transformers, ballasts, starters and other necessary equipment within their individual letters or behind wall.

B. NON-CONFORMANCE

1. No field installation changes are permitted without first notifying Landlord in writing. If in the event any sign is changed as to placement or location, which differs from the plan, the Tenant's sign contractor will be responsible to remove and relocate sign to proper placement at the sign company's expense. The sign company will also repair fascia from where the sign was moved.
2. Any sign that is installed by Tenant which is not in conformance of approved drawings shall be corrected by Tenant within fifteen (15) days after written notice by Landlord. In the event Tenant's sign is not brought into compliance within said fifteen (15) day period, then Landlord shall have the option to correct said sign at Tenant's expense.

SIGNAGE RESTRICTIONS

1. No banners are allowed without expressed written consent of the Landlord.
2. Signs constituting a traffic hazard.

SIERRA LAKES WEST SIGN CRITERIA

3. No person shall install, maintain, or cause to be installed or maintained any sign which imitates in size, color, lettering or design any traffic sign or signal, or any other symbols or characters to interfere with, mislead or confuse traffic
4. Immoral or unlawful advertising is prohibited.
5. Movable/portable signs except as provided in this document are prohibited.
6. Permanent advertising devices such as attraction boards, posters, banners and flags, except where specifically approved by the Owner/Developer and the City, are prohibited.
7. Luminous vacuum-formed acrylic signs and letters including pre-manufactured and franchise signs are prohibited.
8. Paper, cardboard or styrofoam, stickers or decals hung around, on or behind storefronts are prohibited, except for vinyl lettering providing store name, hours of operation and contact information.
9. Simulated materials (I.e. wood grained plastic laminates) or wall coverings are prohibited.

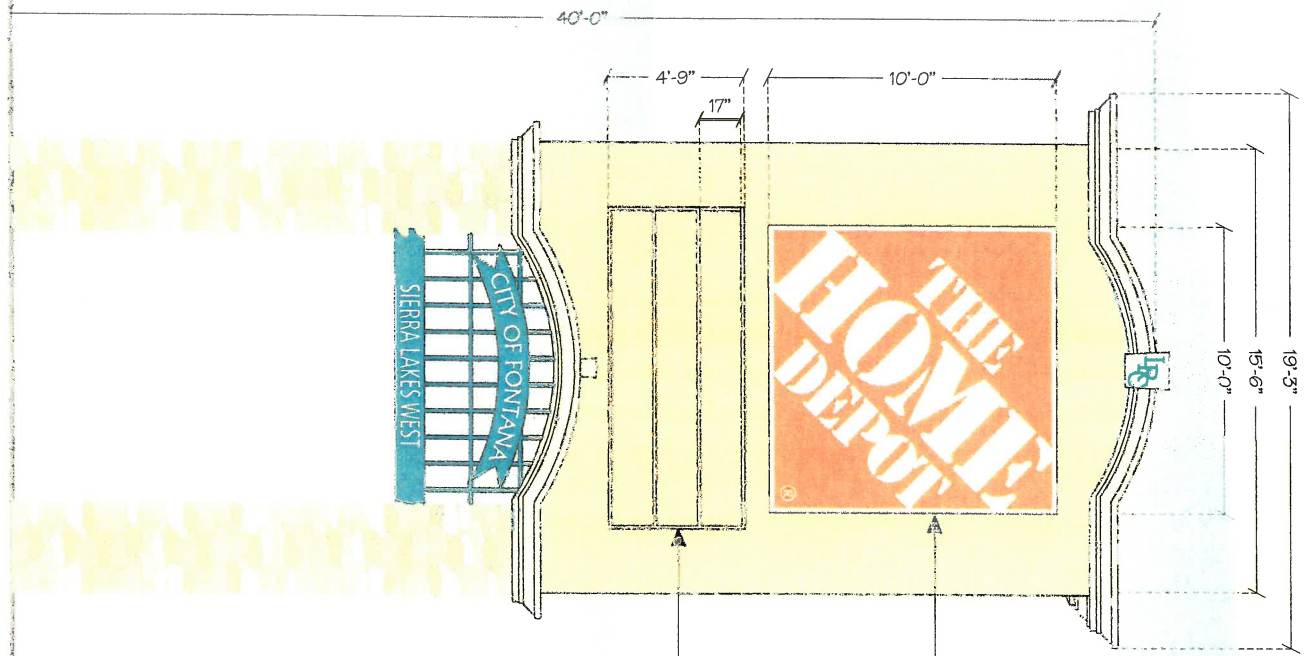
